## City Updates

- Mayor Woodward will host a series of town hall meetings in May to discuss the City's finances and priorities for the 2024 budget and collect feedback on City services.
  - Town hall meetings will be held from 5-7pm at the:
    - South Hill Library, 3324 S. Perry St., on May 2
    - Hillyard Library, 4111 N. Cook St., on May 9
    - Shadle Park Library, 2111 W Wellesley Ave, on May 11
- [Highlights of the Point-in-Time Count](#), a federally required annual snapshot estimate of Spokane County's homeless population that relies on volunteers and helps regional planners determine programs, have been released.
- From 2016 to 2021, the [City worked with Washington State Department of Ecology](#) to clean up and redevelop areas of Riverfront Park. The [partnership](#) leveraged public and private funds to increase the park's diversity and accessibility, making it Spokane's No. 1 gathering space. The cleanup earned the City and Ecology a [Phoenix Award for brownfields excellence](#) at the national Brownfields Conference in Oklahoma City.
- The City's Community, Housing, and Human Services Department is requesting public feedback through Friday, May 5, on priorities for its next award cycle through a short [survey](#). The federal, state and local funds for the annual cycle will result in an annual investment of \$7.4 million for homeless services, housing and public service projects. [Take the survey](#).
- [Take the North Spokane Corridor Connection to I-90 survey](#) and attend the upcoming community workshop on May 10th at the Hive (Sprague Ave.) from 5:30 – 7:00 pm.
- [Ordinance proposal would make public drug use illegal](#). The ordinance was announced on March 21, by Mayor Nadine Woodward and Council Members Jonathan Bingle and Michael Cathcart. Additionally, 28 Mayors, including Woodward, voice concern about drug laws, [read the letter](#).
- Curbside [yard and food waste service](#) runs through November. Residents are reminded that cart lids must be closed completely when placed at the curb.
- Spokane Transit Authority (STA) is planning to introduce its new Bus Rapid Transit line, the City Line, July 2023. To better align growth with projected resources, **STA is proposing to revise previously approved service plans**. Take the [survey](#) to provide feedback to STA on proposed changes.
